CALIFORNIA PEACE OFFICERS' MEMORIAL FOUNDATION JOHN F. DUFFY SCHOLARSHIP/GRANT PROGRAM

Dependents of California peace officers who have died in the line of duty are eligible to receive annual scholarships from the California Peace Officers' Memorial Foundation.

Scholarships are awarded on an annual basis. All dependents of California peace officers that have died in the line of duty, regardless of how long ago, are eligible. Approval of applications will not be based upon sex, age, race, creed, national origin, or religious preference, or restricted based upon the applicants' field of endeavor. The criteria to be used in granting scholarships may include; academic achievement, financial need, school activities, and community service.
