I can honestly say as I attended several of them with an open heart that much love, thought and care was put into each and every one of them by the law enforcement family. For this, I whole heartedly thank all of you that made them happen. Thank you for keeping our loved one's memory alive. It is one way a survivor is able to move forward in his/her life.

Some information about me, even though it has been a little over three years since my husband, Correctional Officer Gilbert Cortez and his K-9, Mattie's E.O.W., I have come to an important realization about grief. Being pulled out of my kindergarten classroom on March 25, 2013, my life completely changed when I was told the tragic and horrific news that my husband had died in a car accident. I took time off to grieve and mourn him and also to pick up the pieces of my now messy and broken life. This year I finally felt my calling to teach again. And I'm so happy I did return because at the end of this school year, I discovered that another way to help me move forward and to "rebuild my shattered life," is by doing acts of kindness - an important lesson I have tried to teach my kindergarteners. It's a simple message, be kind to others and do something nice for them, you don't know what they have been through.

As a new survivor, I challenge all of you reading this, to go out and do well by helping someone in need. I promise you, as I told my 32, five-year olds, your heart will feel happiness when you do something kind to help your neighbor. It won't cost you anything, just go out and pay it forward. We truly get more in return in doing a good deed for another human being than by expecting something from them. And as Ronald Reagan simply stated, "We can't help everyone, but everyone can help someone."




